# Ocean Wise Conservation Organization Ocean Bridge Urban Learning Journey & National Youth Summit Contest Official Rules

#### NO PURCHASE NECESSARY

**ELIGIBILITY**: This contest (the "Contest") is open only to participants and alumni of the Ocean Bridge Classic program, who are 18 years of age or older at time of entry. Employees of the Ocean Wise Conservation Organization ("**Sponsor**"), and their respective affiliates, subsidiaries, advertising and promotion agencies (collectively, the "Promotion Entities") and the immediate family members and/or those living in the same household as such person, are not eligible. All federal, provincial and local laws and regulations apply.

The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsor for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right, in their sole discretion; to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

PARENTAL CONSENT: All entrants who are eighteen (18) years of age or younger must submit with their entry a signed Parental Consent Form, which may be downloaded via at [add form here]

# **HERE'S HOW IT WORKS:**

Throughout the ULJ ambassadors and alumni will have the opportunity to add their name to a final raffle, which will be drawn during the Nation Youth Summit. The rules are simple - for each event that you participate in or challenge that you complete AND that you report participating in or completing will add your name to the final draw (ex: If you go to and report your participation in 10 events, you will have your name entered 10x in the raffle). It is up to you to self-report your participation to increase your chances of winning a prize at the end. Reporting will take place here: ULJ Event Participation Form.

To make sure that people are participating in the events, each group must come up with a code word that they will share during their event. Ideally, this code word should connect back to your project, or ocean/freshwater conservation more generally.

We will have a total of 30 prizes available to win. Each person who enters will only be eligible to win one prize regardless of how many times their name is entered into the raffle. People's names will be collected through the form and assigned a number (I.E. If I entered my name four times, I might win if numbers 3, 34, 101, or 192 are drawn). On March 5<sup>th</sup>, during the National Youth Summit, we will use a random number generator (set between 1:N, N being the number

of people who enter) to pick numbers at random. The winners will have the chance to pick a prize from the 30 available prizes with the first name drawn going first, the second – second, etc. The Ocean Bridge program will cover all costs associated with shipping items winners.

# ALL ENTRIES FROM PERSONS AGE EIGHTEEN (18) OR YOUNGER MUST BE ACCOMPANIED BY A PARENTAL CONSENT FORM DESCRIBED ABOVE.

The chances of winning will depend on the number and caliber of entries, and on the decisions of the judging panel, which are discretionary and final. Only entrants who enter during the Entry Period, will be eligible to win. Any entry that fails to meet the submission criteria will not be entered into the Contest.

# **AVAILABLE PRIZE(S)**

There are a total of 30 prizes available to win. The odds of winning are dependent on the number of entries. We will have a mix of regional + national prizes. Winners will have the option to pick a prize from the national and regionally appropriate prizes based on the order of when their name was called.

Prize(s) is/are non-transferable. Prize(s) consist only of elements listed above and does not include transportation to/from Vancouver, accommodation or any other travel-related or other expenses.

# **TERMS OF SUBMISSION:**

By participating in the Contest, each entrant agrees to be bound by these Rules and by the interpretation of these Rules by the Sponsor. By submitting an Entry, entrants represent, warrant and agree that they are the sole creator of the Entry. Entrants must have all rights, approvals and/or consents necessary to submit their Entry on the terms provided and represent and warrant that their Entry does not violate these Official Rules, or the rights of any other person or entity or any law. Entries must be in English. Entries must comply with all applicable federal, provincial and local laws, rules and regulations including, but not limited to, those concerning defamation and invasion of privacy, and must not infringe on the copyrights or trademarks of another party, as determined by Sponsor. If an Entry includes such material or an element contained in an Entry is deemed unsuitable for public presentation (e.g., contains personal information, gratuitous violence, inappropriate acts or language, etc.), unfavourably depicts Sponsor, slanders brands or individuals, contains hate speech or is inconsistent with the theme or image of the Contest, Sponsor reserves the right, in its sole discretion, to disqualify the Entry.

- (i) answer skill testing question

- (iii) agrees to release the Promotion Entities against any and all claims, damages, liabilities, costs, and expenses arising from any liability in connection with this Contest, the selected entrant's participation therein and/or the awarding and use/misuse of the Prize or any portion thereof;
